Heard. **Rule**. Rule made returnable forthwith. Heard finally by consent of the learned counsel appearing for the parties.

- 2. These three petitioners are by siblings and therefore the facts in W.P. No.5564/2016 are being considered for the purpose of deciding the claim.
- 3. The Scrutiny Committee by the impugned decision has invalidated the tribe claim of the petitioners of belonging to Schedule Tribe "Raj" in entry 18 for the State of Maharashtra in the Presidential (Scheduled Tribe) Order 1950.

4. The genealogical tree is at page No.65. The learned AGP does not dispute the genealogical tree. She also does not dispute the documents i.e. birth certificates and school leaving certificates of grandfather of the petitioner, father of the petitioner and uncle of the petitioner and the entries made therein. The following chart would demonstrate the position of these certificates and their dates:-

5. What is material to note is that all of these entries, which are pre-constitutional, indicate that the caste of the petitioner's grandfather Madhao S/o Sitaram, father Pralhad and uncle Vishwnath is recorded as "Raj". The birth certificate of Madhavrao Sitoba Raj, who is the grandfather of the petitioners, record his date of birth as 29.05.1918 and the surname of the father is "Raj" (page 43). This is duly supported by the corresponding entry (page 68) which is the extract of the Birth and Death Register for the month of


May 1918. The School Leaving Certificate of Jagannath, who is the real uncle of the petitioner, which is dated 24.04.1940 also records the caste as "Raj" (page 45). The corresponding entry in that regard in Date & Birth Register of Jagannath is 30.07.1928 (page 69). The School Leaving Certificate of Parlhad s/o Madhav dated 27.01.1989 also records the caste as "Raj" and the duration for which he has studied in the Karanja Nagar Parishad, School No.3, as 18.06.1943 to 01.05.1947 (page 41). There are other documents as indicated in the table above which also demonstrate that the caste of the grandfather of the petitioner Madhavrao Sitaram Kelkar has being recorded as "Raj", all of which are pre-constitutional documents. Impugned decision of Scrutiny Committee dated 16.09.2016 (Page 27) does admits this position in para No.1, however, it inexplicably rejects the claim on the ground that the entries do not describe them as "Raj" Schedule Tribe by ignoring the position that the Presidential Notification declaring the tribe "Raj" as a Schedule Tribe is dated 29.10.1956.

6. In a series of judgments, right from *Apoorva D/o Vinay*Nichale Vs. Divisional Caste Certificate Scrutiny Committee No.1 and others, 2010(6) Mh.L.J. 401, Maharashtra Adiwasi Thakur Jamat Swarakshan Samiti Vs. State of Maharashtra, 2023(2) Mh.L.J. 785 to Priya Gajbe Vs. State of Maharashtra, 2023 SCC Online SC 909, it

has been consistently held that pre-constitutional documents have greater evidentiary value and entries made therein can be safely relied upon. However, ignoring this dictum, merely on the above ground, the learned Scrutiny Committee has rejected the claim.

- 7. In view of the entries made in the School Leaving Certificates, Birth and Death registers, all of which pre-constitutional documents and have not been disputed by the learned AGP, since they record the caste as "Raj" of the grandfather, father and uncle of the petitioner and the fact that these documents and the entries made therein are not disputed by the learned Assistant Government Pleader Smt. Kalyani Deshpande, there cannot be any two opinions about the veracity and genuineness of the entries made therein, which unequivocally demonstrate that the ancestor of the petitioner belong to the Tribe "Raj" which has been declared as a Schedule Tribe by way of amendment dated 29.10.1956 in entry 12 (Part IV) which has been carried forwarded as entry 18 in the amendment to the Presidential (Scheduled Tribe) Order 1950, dated 18.09.1976.
- 8. In that view of the matter, the impugned decisions of the Scrutiny Committee cannot be sustained and same are hereby quashed and set aside. The Scrutiny Committee is directed to issue caste validity certificates to the petitioners as they belong to "Raj"

Schedule Tribe as per entry 18 of the State of Maharashtra in the Presidential (Scheduled Tribe) Order 1950. The Committee shall issue the certificates to the petitioners by 11.09.2023. The learned AGP to communicate this decision to the Scrutiny Committee.

9. In the circumstances there shall no order as to costs. Rule is made absolute in the above terms.
