Oral Judgment (Per R.K. Deshpande, J.):

1. Rule, made returnable forthwith. Heard finally by consent of the learned counsels appearing for the parties.

- 2. The policy of retaining the husband and wife at the same place, contained in the Government Resolution as dated 27-2-2017, has not been followed. The explanation furnished is that the post is not available so as to accommodate the petitioner within the radius of 30 kms. Further assurance is given that while effecting the transfer at the end of the academic session, the case of the petitioner shall be considered, if the post is found available.
- 3. Rule accordingly. No order as to costs.
