2. Rule. Rule made returnable forthwith. Heard finally by consent.

- 3. In this case, there are many documents which clinch the issue in favour of petitioners. There are two certificates of validity granted to uncles of petitioner, by the Committee at Gadchiroli vide Certificate Nos.1885503 and 122300. By these certificates, the social status of Shramrao Dharne and Mangal Dharne has been validated to be that of "Mana" Scheduled Tribe. P-I Revenue document shows Jana s/o. Sago as belonging to 'Mana'` caste. There is no dispute about Jana being related to the petitioner as being the petitioner's common ancestor. The validity certificates issued by Gadchiroli Committee to petitioner's paternal uncles have not been disputed by the Committee.
- 4. The above referred factual situation would show that this case is squarely covered by the view taken by this Court in two writ petitions, namely, Writ Petition No.2834/2018, decided on 31st January, 2019 and Writ Petition No.2713/2014, decided on 20th March, 2019.
- 5. In this view of the matter, we are inclined to allow this petition and it is allowed accordingly.
- 6. The impugned order is hereby quashed and set aside.
- 7. The respondent No.1/Committee is directed to issue validity certificate in the name of the petitioner within four weeks from the date of receipt of this order.
