- 1. Heard learned counsel for the parties. Rule. Heard forthwith by consent of parties.
- 2. Both these petitions are filed by members of one and the same family. Writ Petition No. 3371 of 2018 has been filed by petitioner Sudhakar Dharne who is father of petitioners Pratiksha and Parimal in Writ Petition No. 3373 of 2018.
- 3. The ground commonly relied upon by the petitioners for issuance of direction to respondent no. 1 Committee is that real cousin brother of petitioners Pratiksha and Parimal and nephew of petitioner Sudhakar by name Dipak Shalikram Dharne has been granted validity as he belonging to "Mana" scheduled tribe by the Committee for Nagpur Division on 14.3.2006. There is no dispute about the grant of validity to the blood relation on paternal side of the petitioners and, therefore, going by the settled principles of law, we see no reason as to why the petitions should not be allowed.
- 4. Writ Petitions are allowed. The impugned orders are hereby quashed and set aside. It is directed that respondent no. 1 Committee shall issue the validity certificate to the petitioners as they belonging to



"Mana" Scheduled tribe within four weeks from the date of receipt of this order.

- 5. Rule is made absolute in the above terms. No costs.
