ORAL JUDGEMNT (Per S. V. Gangapurwala, J.):

- 1. Rule. Rule returnable forthwith. With the consent of learned Counsel for respective parties matters are taken up for final hearing.
- The caste claims of the petitioners as Rajgond is invalidated.
- 3. Yeramwar, learned Counsel for the Mr. petitioners submits that the committee verified the census documents of the year-1951. The name of the great grandfather of the petitioner Iragond is recorded and is shown to belong to Rajgond, Scheduled Tribe. The school record of the grand father of the petitioner of the year 1964 also records caste as Rajgond. There is not a single contra evidence on record. Initially, in the caste column in the school record of the father of the petitioner the caste was recorded as

Telang is not a caste at all. After due permission the same is corrected to Rajgond. In case of school record of the uncle, initially Gondkalal was mentioned the same was corrected as Rajgond. In fact, Gondkalal is not a caste at all. Gond is now a separate scheduled tribe and Gondkalal is not a caste. The learned Counsel submits that old record consistently shows the caste of the petitioners family as Rajgond.

- 4. The learned Counsel further submits that affinity test is not the litmus test. The learned Counsel relies on the judgment of the Apex Court in case of Anand V/s. Committee for Scrutiny and Verification of Tribe Claims and others reported in 2011 AIR (SCW) 6559.
- 5. Mr. Lakhotiya, the learned A.G.P. submits that in the school record of the petitioner's father the caste was recorded as Telang and the same is subsequently corrected. In case of uncle also the caste was recorded as Gondkalal subsequently it is corrected as Rajgond. The

petitioner failed in the affinity test also. In one of the relative of the petitioner namely Iragond Lingagond the entry of the case is interpolated. The learned A.G.P. further submits that the caste Telangi is in V.J. category. The petitioners failed in the affinity test. All these aspects was rightly considered by the committee.

- 7. We have considered the submissions canvassed by the learned Counsel for respective parties.
- 8. The committee has relied upon the sensors record and found the caste of the great grandfather of the petitioner Iragond recorded as

Rajgond. The committee has also doubted entry of caste recorded Raigond in of the as case grandfather of the petitioner namely Lalagond Iragond. In case of the uncle of the petitioner the caste was recorded as Gondkalal. Gondkalal is not a caste. Now Gond is a separate Scheduled Tribe and Rajgond is also Scheduled Tribe. said entry is corrected as Rajgond and in one entry the entry of Rajgond was recorded. It cannot be said to be a contra entry. The entry appears to be Rajgond of the year-1987.

- 9. Old entries have more probative value and also there are no contra entries of caste recorded. The affinity test is not the litmus test as is held by the Apex Court in case of *Anand* (Supra).
- 10. In light of the above, the impugned judgments are quashed and set aside. The committee shall issue the validity certificate to the petitioners of Rajgond, Scheduled Tribe immediately.

- 11. Rule is accordingly made absolute in above terms.
- 12. Writ Petitions are accordingly disposed of. No costs.
