RULE. Rule made returnable forthwith and heard finally by consent of parties.

2] The petitioner cousin sisters are claiming to be belonging of Mana Scheduled Tribe. Thier caste claims were rejected by the respondent no.1-Committee vide it's common order dated 10.04.2018. Learned Counsel for the petitioners submit that despite pre constitutional documents from the year 1923 onwards, the Committee has rejected the claim. It is also submitted that the previous validities issued in the name of the blood relatives of petitioners were not considered by the Committee.

3] Learned Additional Government Pleader Shri S.M. Ukey after considering the available material and upon instructions made statement that caste validity certificate will be issued to the petitioner within one week.

4] In view of that, the impugned order dated 10.04.2018 passed by the respondent no.1-Scrutiny Committee is set aside. Respondent no. 1 is directed to issue caste validity certificate to both the petitoners within two weeks from the date of this order.

5] Rule is made absolute in the aforesaid terms. No costs.
