- (a) The impugned orders passed by the Scrutiny Committee invalidating the tribe/caste claims of the Petitioners are set aside.
- (b) We direct the competent Scrutiny Committee to scrutinize and verify the claims of the Petitioners as belonging to “MANNERVARLU” Scheduled Tribe (Entry 27) on merits and in accordance with law.
- (c) The Scrutiny Committee should overlook the mistake and error in the spelling of the tribe/ caste in the certificates issued by the Sub Divisional Office.
- (d) The Scrutiny Committee shall complete this assignment as expeditiously as possible.
