## ORAL JUDGMENT (Per Pushpa V. Ganediwala, J.)

- Rule. Rule is made returnable forthwith. Heard finally by consent of the learned counsel for the parties.
- 2. We have heard Mr. P. P. Dhok, the learned counsel for the petitioner, Mr. B.M. Lonare, the learned Additional Public Prosecutor for respondent nos.1, 2 and 5 and Mr. S. A. Marathe, the learned counsel for respondent no.4.
- 3. By this petition, the petitioner challenges the order dated 16.01.2018 passed by respondent no.2 Scheduled Tribe Certificate Scrutiny Committee, Gadchiroli, thereby invalidating the caste certificate issued by respondent no.5 Sub-Divisional Officer, Warora, district Chandrapur.
- 4. The petitioner, in support of her claim to be of 'Mana Scheduled Tribe', has filed on record a bunch of documents, which includes the pre-constitutional documents too. The pre-constitutional documents which are revenue documents of the year 1918 1919 showing that Bhagu W/o Dagdu Mana, grandmother of

the petitioner from paternal side as belonging to "Mana" caste. In addition to it, there are number of validity certificates, the copies of which are placed on record, issued to the blood relatives of the petitioner from paternal side namely Vijay Vithal Shende (Sr.No.45679), Nilesh Mahadeorao Shende (Sr. No. 44378), Bhalchandra Natthuji Shende (Sr.No. 44374), Vijay Vitthal Shende (Sr.No.45679), Arvind Vijay Shende (Sr.No.46746) and Manisha Vijay Shende (Sr. No. 45486) showing their social status to be of "Mana – Scheduled Tribe, issued by the Scheduled Tribe Certificate Scrutiny Committee, Nagpur Division.

- 5. Apart from this, police verification report which was produced before the Scrutiny Committee is also in favour of the petitioner. All these fact situations would show that this case is squarely covered by the judgment of the Division Bench of this Court rendered in Writ Petition No. 4799/2018 dated 07.01.2019.
- 6. In this view of the matter, we are inclined to allow this petition and it is allowed accordingly. The impugned order dated 16.01.2018 passed by respondent no.2 Scheduled Tribe Certificate Scrutiny Committee, Gadchiroli is quashed and set aside. The

respondent no.2 – Committee is directed to issue validity certificate in the name of the petitioner within Four weeks from the date of receipt of this order.

Rule is made absolute in the aforesaid terms. No order as to costs.
