

## PER COURT:-

- The tribe claim of petitioners as Koli Mahadev, Scheduled Tribe is invalidated.
- 2. Jadhavar, learned counsel and Mr. Mr. Boinwad, learned counsel for petitioners submits that the entries in the school record



- 3. Mr. Patil, learned A.G.P. submits that there is a contra entry in the school record of the real uncle of petitioners namely Laxman Sakahari Salunke of the year 1973 recording caste as Hindu Koli. In view of the contra evidence, the affinity test becomes relevant. The petitioners are failed in affinity test. In view of the contra entry and the failure of the petitioners in the affinity test, the committee has rightly invalidated the tribe claim of petitioners.

- 6. The vigilance has been conducted. The vigilance cell did not find interpolation in any of the entry in the school record of the petitioners and their relatives except one isolated entry of school record of uncle of the petitioners namely Laxman Sakahari Salunke of the year 1973. All entries from 1969 record caste as Mahadev Koli.
- 7. The Apex Court has also in case of **Anand Vs. Committee** (supra) held that the affinity is not litmus test.
- 8. Considering all the aforesaid aspects of the matter that is consistent entries since the



year 1969 in the school records of the petitioners, their father, uncles, relatives as Mahadev Koli barring one isolated entry of the year 1973 and also considering the original place of residence of petitioner, we pass the following order:

## **ORDER**

- i. The impugned order is quashed and set aside.
- ii. The committee shall issue validity
   certificate to petitioners of Koli Mahadev,
   Scheduled Tribe immediately.
- 9. Writ Petitions are disposed of. No costs.
- 10. In view of disposal of writ petitions, present civil application stands disposed of.
